WARRANTY DEED

STATE OF GEORGIA COUNTY OF HOUSTON

This Indenture, made this 23rd day of December, in the year Two Thousand Two between MARK E. BAYER (a one-third interest) and WARNER ROBINS SUPPLY COMPANY, INC. (a two-thirds interest), of the County of Houston, State of Georgia, as party or parties of the first part, hereinafter called Grantor, and UNITED WAY OF CENTRAL GEORGIA, as party or parties of the second part, hereinafter called Grantee (the words "Grantor" and "Grantee" to include their respective heirs, successors and assigns where the context requires or permits).

WITNESSETH that: Grantor, for and in consideration of the sum of Charitable Donation of Equity and Ten and 00/100 (\$10.00) Dollars and other good and valuable considerations in hand paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, aliened, conveyed and confirmed, and by these presents does grant, bargain, sell, alien, convey and confirm unto the said Grantee,

See Exhibit "A" attached hereto and by reference made a part hereof.

This conveyance is being made second and inferior to that certain Deed to Secure Debt in favor of Security Bank of Houston County successor to Crossroads Bank of Georgia per Deed Book 1202, Page 226, Clerk's Office, Houston Superior Court.

The conveyance evidenced hereby is intended, by Grantor hereof, to be a charitable contribution in accordance with applicable United States law to a charitable organization, the Grantee hereof.

This Deed is given subject to all easements and restrictions of record, if any.

TO HAVE AND TO HOLD the said tract or parcel of land, with all and singular the rights, members and appurtenances thereof, to the same being, belonging, or in anywise appertaining, to the only proper use, benefit and behoof of the said Grantee forever in FEE SIMPLE.

AND THE SAID Grantor will Warrant and forever defend the right and title to the above described property unto the said Grantee against the claims of all persons whomsoever.
